## ZHAILAU 2010 IMPORTANT PAYMENT DETAILS

To qualify for the lowest rates – *the Early Bird Special* – first deposits must be received no later than February 22, 2010.

- ✦ First deposits will be accepted until all available accommodations are full. If a deposit is received when all accommodations are full, it will be fully returned at no cost to the registrant.
- ✦ Registrants will be assigned to accommodations based on need and on a first-come, first-serve basis upon receipt of their registration forms and nonrefundable deposits by the Kazakh Aul of the US. First and second choices for accommodations must be noted on the registration form. Families will be notified of their accommodations after they are assigned
- ✦ You may pay in full at registration, or if you are registering prior to April 30th, you may opt to make three payments according to the following schedule:
  1. Due with registration: A *nonrefundable* first deposit of \$150.00 per person attending. This deposit will be a nonrefundable first payment for Zhailau participation.
  2. Due by April 30, 2010: a second *nonrefundable* deposit of \$150.00 per person attending.
  3. By June 11, 2010: All balances are due in full
- ✦ Reservations made after April 30, 2010 must be paid in full with registration.
- ✦ *All payments must be paid on time and it is the registrant's responsibility to submit all payments by the above noted dates. Failure to make any of the scheduled payments by their due dates may result in revocation of your Zhailau summer camp reservation and forfeiting of deposit(s) paid.*

**REGULATIONS REGARDING RESPONSIBILITY FOR THE CARE AND SUPERVISION OF PARTICIPANTS' CHILDREN**

- ✦ Parents are responsible at all times for their children at Zhailau. The Kazakh Aul of the US cannot and will not assume responsibility for the care or supervision of people's children.
- ✦ The Geneva Point Center's new executive director has informed us that ALL children, regardless of age, must be supervised by an adult at all times. This includes anyone under the age of 16.
- ✦ It is the responsibility of each parent or guardian to ensure that his/her child(ren) are respectful of Geneva Point Center and Kazakh Aul of the US property (e.g., equipment, games, books, facilities, instruments, etc.). Parents will compensate the Geneva Point Center and/or the Kazakh Aul of the US for any damages incurred by themselves or their children.
- ✦ Due to safety concerns, NO children under the age of 18 will be allowed into the cooking area during Kazakh Cooking.
- ✦ Bike riders are required to wear helmets at all times, must yield to pedestrians in walkways, observe reasonable speeds, and must respond immediately to any adult request to stop or reduce speed. A formal written bicycle riding permission policy will be sent to all families. Bicycle riding at Zhailau is a privilege which can be revoked by the Kazakh Aul of the US or the Geneva Point Center.

1. The undersigned requests the Kazakh Aul of the U.S., Association for American & Kazakh Families, to reserve accommodations for her/his family and guests listed above for the Zhailau Heritage Camp to be held July 26-31, 2010 at the Geneva Point Center in Moultonborough, NH. By signing below, the undersigned understands that all housing will be assigned based on need and on a first-come, first-served basis, and s/he may not get first choice. Deposits are *nonrefundable*, and the undersigned agrees to comply with the payment schedule.
2. The undersigned, her/his family, and guests agree to abide by the rules and regulations set by the Kazakh Aul of the U.S. and the Geneva Point Center for the health, safety and welfare of all campers.
3.
